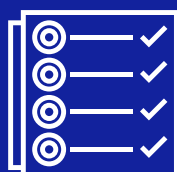
WHAT DOCUMENTS WILL YOU NEED TO REGISTER YOUR COMPANY ONLINE?

Scanned copy of PAN Card or Passport
(Foreign Nationals & NRIs)



Scanned copy of Voter's
ID/Passport/Driver's License

Scanned passport-sized photograph
specimen signature
(Director Only)



Scanned copy of No-objection
certificate from the property
owner

Scanned copy of Sales/Property
deed in English (in case of owner
property)



WHAT DOCUMENTS WILL YOU NEED FOR GST REGISTRATION ?

- **For a Proprietorship**
 - PAN Card
 - Address proof of proprietor
- **LLP**
 - PAN Card of LLP
 - LLP Agreement
 - Partners' names and address proof
- **Private Limited Company**
 - Certificate of Incorporation
 - PAN Card of Company
 - Articles of Association, AOA
 - Memorandum of Association, MOA
 - Resolution signed by board members
 - Identity and address proof of directors
 - Digital Signature

WHAT DOCUMENTS WILL YOU NEED FOR FSSAI REGISTRATION ?

- **Business Registration Proof**
 - Certificate of Incorporation or GST certificate or MSME certificate or Trademark certificate, etc. (Any One)
- **Photograph**
 - Director/ Proprietor/ Partner
- **Pan & Adhaar Card**
 - Proprietor/ Director/ Partner of the business.

WHAT DOCUMENTS WILL YOU NEED FOR TRADEMARK REGISTRATION ?

- **ID Proof**
 - Scanned copy of PAN Card of the applicant and ID (Aadhar card/ Voter Card/ Passport/ DL)
- **Address Proof**
 - Latest Bank statement/ Utility bill in the name of the applicant required which should not be older than two months
- **Brand**
 - A soft copy of trademark to be registered
- **Power Of Attorney**
 - Duly signed by the applicant to authorise us to file on their behalf
- **Board Resolution ***
 - Only in case of a company
- **User Affidavit**
 - If a specific user date is to be claimed, the user affidavit is also required to be submitted

WHAT DOCUMENTS WILL YOU NEED FOR DIGITAL SIGNATURE CERTIFICATE ?



- **The following documents are the required to obtain a Digital Signature Certificate for an Indian :**
 - **PAN Card**
 - **Aadhar Card**
 - **Passport size photo**
- **Foreign individuals and organizations looking to obtain DSC must submit:**
 - **Attested copy of applicant's passport**
 - **Attested copy of Visa, if the applicant is out of their native country**
 - **Attested copy of Resident Permit certificate, if the applicant is in India**
 - **Attested copy of any Govt-issued address proof**

WHAT DOCUMENTS WILL YOU NEED FOR ISO CERTIFICATE ?



- **Business Registration Proof**
 - Certificate of Incorporation or GST certificate or MSME certificate or Trademark certificate, etc. (Any One)
- **Photograph**
 - Letter Head or Visiting Card (Any One).
- **Sample Copy**
 - Business Activity/Scope (Which is to be written on certificate).
- **Soft Copy**
 - Sales Invoice, Purchase Invoice, Receipt, Bill (Any One).
